PARTICIPATION AGREEMENT: I, The Renter, understand all of the activities I/we participate in at Driftwood Dance Academy Inc. may involve some degree of risk of strain or bodily injury. I agree to release, waive, discharge, and hold harmless Driftwood Dance Academy Inc., its owners, its instructors and its employees from any liability, claims, actions or losses for bodily injury, property loss/damage, or otherwise which arise out of my/our personal activity during the studio rental provided by Driftwood Dance Academy Inc. I also authorize Driftwood Dance Academy Inc. to take all reasonable steps to respond to medical emergencies and to seek medical treatment in the case of an injury.

RENTAL AGREEMENTS

Should there be damage to any part of the studio (floors, barres, mirrors, equipment, common areas etc.) as a result of the Renters activities during their rental period, all repair expenses will be the responsibility of the Renter to cover.

For Artists: As an artist using studio space for my own practice and rehearsal, I confirm that I am not receiving any payment from the participants that may join me during my booking.
